- create blocks, wood engravings, metal stamps, book engraving, steel stamps, fonts for installation, sticker engravings, copperplates, steel engraving, stamping tools for badges, seals, engravings forms with appropriate technological methods according to the original drawings;
- create the engraving on the medals, plaques, weapons;
- when manufacturing handicraft work ensure aesthetic design of the final product and precise elaboration;
- repair and make reconstruction of damaged parts of the original work;
- use the relevant standards and regulations in the field of conservation;
- prepare the initial and subsequent documentation for the specific job;
- service and perform routine maintenance of machinery, equipment, tools and instruments.

The graduate is employed in the field of hand making craft decorative and utility items made of metals and implementation of the decorative engravings on the objects created in other fields of craft designed by artist or as replicas; in the field of reconstruction and modification of objects made with artistic engraving techniques.
